Limited Entry: Limited entries of 25 dogs per test. Closing date: 12 noon Sept 29, 2021. Day of test entries will be accepted if limit of 25 dogs has not been reached (increased entry fees for day-of-entry).

Testing will be held both outdoors, in a simulation of a farm environment, with chickens on the premises.

- Dogs must remain on leash.
- Please do not visit the test site prior to the test.
- No bitches in season.
